COMMITTEES & AGENDAS:

1. United Nations General Assembly: (SOCHUM)

Preservation of cultural identities with special emphasis on the Defamation of Religion.

The UN General Assembly is the only universally representative body of the United Nations.

The UN General Assembly (UNGA) is the main policy-making, deliberative and representative Organization.

Comprising all Member States, it provides a unique forum for multilateral discussion of the full spectrum of international issues and world affairs covered by the Charter of the United Nations.

The UNGA also makes key decisions for the UN, including:

- Electing the non-permanent members of the Security Council
- Appointing the Secretary-General on the recommendation of the Security Council
- Approving the UN budget
- The UN General Assembly delivers recommendations on many international issues and manages internal UN appointments and budget approval. Each UN member state gets one vote in the assembly.
- It also works for the preservation of cultural identities with special emphasis on defamation of religion.
- Each of the 193 Member States in the Assembly has one vote.
- Votes taken on designated important issues – and decision is made based on majority,
- The Assembly's annual general debate provides Member States the opportunity to express their views on world and international issues. On this occasion, the Secretary-General presents his report on the work of the Organization and the concerning debate topics.

2. United Nations High Commissioner for Refugees (UNHCR)

Assessing the viability of the Principle of Civilian and Humanitarian Character of Asylum. The United Nations High Commissioner for Refugees (UNHCR) is a subsidiary organ of the UN General Assembly, which created it in 1949. It began operating in 1951, and its headquarters are in Geneva.

UNHCR Functions:

- To promote the rights of refugees and to monitor the implementation of the Refugee Convention by its States Parties.
- To protect refugees by working with States on the examination of administrative and legal problems related to the granting of refugee status and to the defence of the right of asylum.
- UNHCR also works with governments to search for durable solutions for refugees.

UNHCR can ensure the protection of refugees by:

- Obtaining information from government concerning the number and conditions of refugees in their territories and the laws and regulations concerning them.
- Endeavoring to obtain permission for refugees to transfer their assets and especially those necessary for their resettlement.
- Promoting the admission of refugees, not excluding those in the most destitute categories, to the territories of States.

3. World Health Organization

Deliberation upon the affects of globalization and capitalism on healthcare with emphasis on private healthcare facilities.

The World Health Organization was established in 1948 and is composed of 193 Member States.

Headquartered in Geneva, Switzerland, the organization's role is to serve as the "authority for health within the United Nations system," and to provide "leadership on global health matters."

Current objectives of the WHO are laid out in a Six-Point

Agenda aimed at responding to the challenges of an "increasingly complex and rapidly changing landscape" of global public health.

The points on the agenda are:

- (1) promoting development;
- (2) fostering health security;
- (3) strengthening health systems;
- (4) harnessing research, information, and evidence;
- (5) enhancing partnerships; and
- (6) improving performance.

This committee is designed for both beginners and experienced delegates alike. Position papers, although strongly recommended, are not required. However, delegates who wish to be considered for an award must submit their position papers by January 27th, 2023, at 23:59 PST.

4. Lok Sabha

Deliberation on religious freedom in India in light of recent developments Lok Sabha is the by-product of the mandate of the populaces in the form of elections and universal adult suffrage. It serves as the central legislative body of the Indian polity and has seen a combination of both, vociferous and reticent speakers while retaining its position of being the primary platform for debate and discussion on issues of national importance.

The Lok Sabha, the lower house of the Indian Parliament, deals with various important issues in India.

Some of the agendas for a Lok Sabha MUN committee include:

- Maintaining the integrity of democracy in the times of Coronavirus with the learnings from the
- 1975 emergency
- Deciding the priority list for administering the Covid vaccine
- Reforms in the election process
- Becoming Atma Nirbhar in the field of agriculture
- Question of the word "Secular" in the Indian Constitution
- Question of Martial Rape

5. All India Political Parties Meet (AIPPM)

All India Political Parties Meet is a forum for unrestricted political debate, discussion and deliberation free from the legislative functions of the parliament, where diverse political personalities and perspectives come together to make decisions on issues of national importance.

It is rightly said that "If freedom of speech is taken away then dumb and silent we may be led, like sheep to the slaughter".

Free speech exists when citizens can express their opinion – including views that are critical towards the government - without fearing negative consequences, such as being put into prison or receiving threats of violence.

Keeping the freedom of each citizen as a priority, this year the Agenda for IMSMUNC'22's AIPPM is "Discussing the freedom of speech and expression in India in light of recent events"
